Message from the Dean

We are Hong Kong's most enterprising and dynamic Faculty of Law. You will be given the opportunity to join a co-operative and innovative community dedicated to teaching, research, and international exchange bringing the best of China to the world and the best of the world to China.

The 2009-2010 Academic Year was a year full of excitement and achievement for the Faculty. Along with the whole Faculty, I was particularly pleased with the achievement of our students in mooting. A moot is a hypothetical case in which law students present written and oral arguments in a courtroom simulation. The Philip C. Jessup Moot ('the Jessup Moot') in international law advocacy is the oldest, largest and most prestigious mooting competition in the world. Hong Kong has participated in the Jessup Moot since 1985. Since only one team from Hong Kong is eligible to progress to the world finals in Washington, D.C., the three local law schools have to first compete in a regional championship. For the past two years, our students from the Chinese University of Hong Kong have won the Hong Kong regional championship and advanced to the world finals in Washington, D.C. This year, our team won the Hardy C. Dillard Award for presenting the best written arguments at the Philip C. Jessup International Law Moot Court Competition in which 127 teams, regional winners from all corners of the world, participated. Our team also achieved an overall ranking of nineteenth in the world from among over 500 teams. The incredible achievement

of our students is not only a tribute to the inspirational coaching of our teachers and the dedicated work of our students, but it also highlights the success of legal education at The Chinese University of Hong Kong.

As regards teaching and learning, the Faculty has developed the *Refugee Internship Programme* as an elective course. The *Refugee Internship Programme* allows our undergraduate law students an exciting opportunity to assist real clients using their legal skills and knowledge. Students partner with experienced lawyers from the *Hong Kong Refugee Advice Centre* to assist asylum seekers with their claims before the United Nations High Commissioner for Refugees.

Also this past year, the Faculty has launched a unique *Virtual Career Resources Centre* which provides students with on-line career resources, career-related programmes and information. The Centre also serves as a contact point to prospective employers.

I am also very pleased to see our first class of LLB graduates this year. Before the end of their final term of studies at the University, around 80% of these graduating students have already received conditional offers from our own PCLL programme. Of those not joining our PCLL, they have great adventures planned. As an example, one of these graduates has been awarded the prestigious Sir Edward Youde Memorial Fellowship to pursue postgraduate study at the University of Oxford.

The Faculty is innovative and responsive to the changing needs of the legal professions in the new century. We offer opportunities and challenges to talented people. Join us and explore this exciting and rewarding journey yourself!

The Bachelor of Laws (LLB) Programme

Double Degree Options

Our flexible double degree programmes allow students to pursue a path that fits them best. Students will be given the opportunity towards the end of their first year to choose the double degree programme (with one extra year of study) that they would like to pursue. The double degree options currently offered to our students include:

1. Bachelor of Laws – Bachelor of Business Administration (LLB-BBA)
2. Bachelor of Laws – Bachelor of Arts (Translation) (LLB-BA(Translation))
3. Bachelor of Laws – Bachelor of Social Science (Sociology) (LLB-BSSc(Sociology))

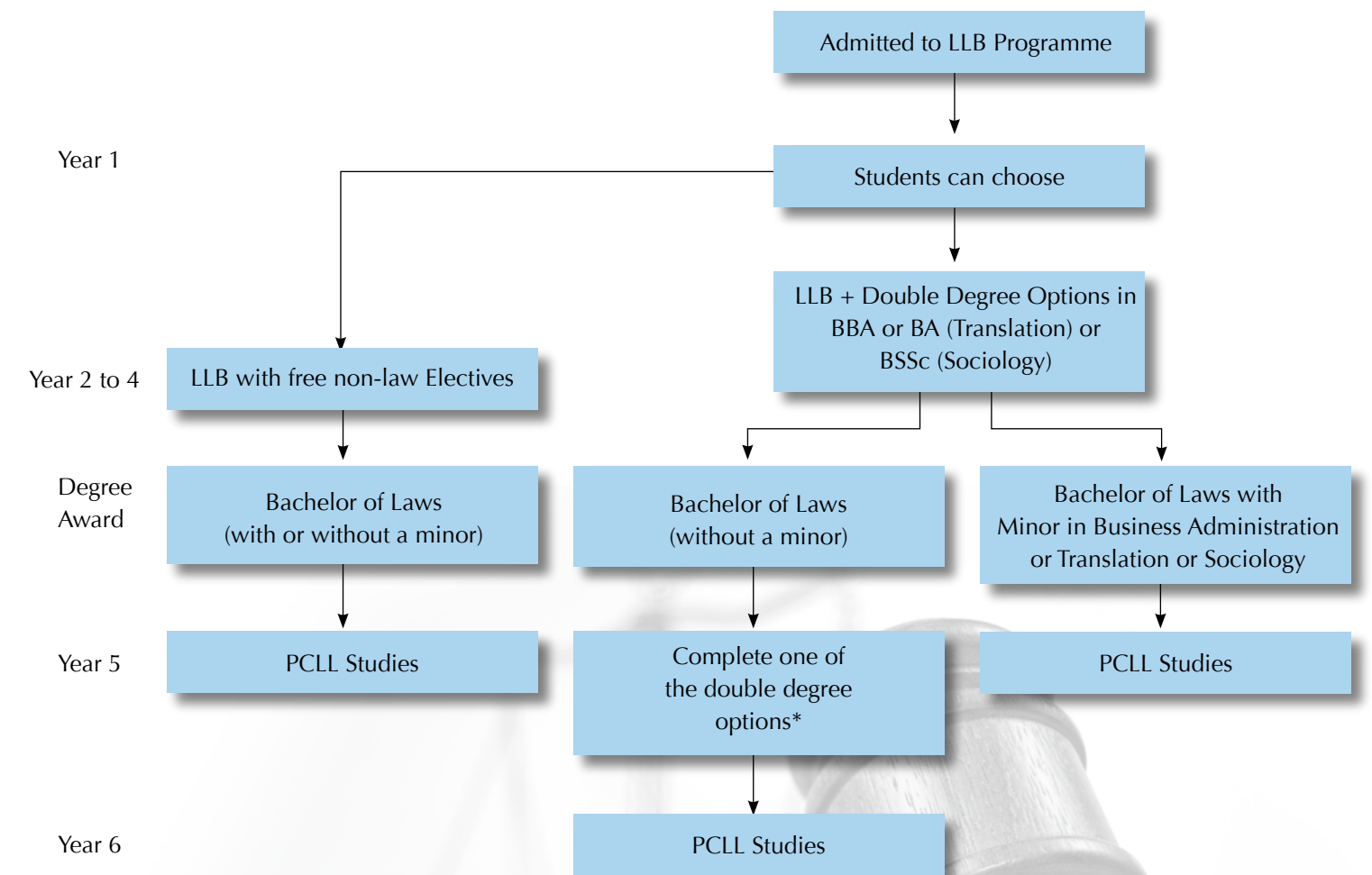
A Flexible Approach

Students who choose to opt out from the double degree option will graduate after four years with the LLB degree and, subject to completing the specific course requirements, a minor in the second degree (Business Administration, Translation or Sociology). For those who need time to pursue their career after completion of the first degree, they may defer the completion of the second degree for up to three years. Graduates may also further their legal education by studying the Postgraduate Certificate in Laws (PCLL).

Students who do not enrol in any double degree option may graduate with the LLB degree with up to two minors in any discipline.

Learning Environment

The Faculty of Law provides first-class learning facilities for our community of scholars, students and teachers. We offer an interactive learning environment, with an emphasis on teamwork and IT support, to facilitate independent research and learning using the resources of our Law Library and specially designed facilities, including the state-of-the-art Moot Courts and the Graduate Law Centre.

The Lee Quo Wei Law Library

The Faculty of Law is adding to one of the fastest growing law collections in Asia by building upon an already extensive library of books and periodicals. Housed in the University Library on the 3/F and 4/F, the Law Library consists of approximately 83,000 volumes of books and bound periodicals on law and law-related subjects, including 630 active serial titles and over 300 multimedia items. This collection is complemented by access to a growing array of online sources, 2450 e-journal titles, and 53 databases, as well as the interdisciplinary collections housed in the University library system.



Moot Courts

The Faculty has two Moot Courts, one in the Main Campus at Shatin and one in the Graduate Law Centre in Central. They are excellent teaching facilities for Advocacy, Mooting classes and many other law courses and competitions. These impressive world class facilities have attracted visiting scholars and professionals to hold their conferences and international symposia in the Moot Courts.



Graduate Law Centre

Located in the heart of Hong Kong's central business district, our Graduate Law Centre in the Bank of America Tower provides an ideal environment for educational activities, academic seminars and international conferences. LLB students have the opportunity to attend guest lectures and to participate in activities held at the Centre designed to give students the opportunity to develop their connections with the legal profession.



Our International Academic Staff

The Faculty has a strong team of experienced academic staff from various jurisdictions from around the world. Aiming to provide leadership in teaching and learning, our teaching staff are committed to educating students in the law through innovative teaching approaches and by drawing on their diverse professional and jurisdictional experience.



Professional Development Opportunities

Distinguished Professional Mentors

Each of our undergraduate students is paired with a Distinguished Professional Mentor (DPM). The DPMs are drawn from branches of the legal profession, the Government and the Judiciary. The DPM helps and guides the student throughout their four years at the Faculty of Law. DPMs act as an advisor on professional and ethical matters and share with the students their own experiences of a career in the law.

The Distinguished Professional Mentor Scheme is the first step in providing students with the skills and confidence to enable them to contribute their best to the community. The relationship between the DPMs and students is special and provides a golden opportunity for students to gain an insight into a career in law and to develop their own sense of their future career development.

Academic Mentors

In addition to the Distinguished Professional Mentors, our teachers act as academic mentors to advise students on all aspects of their academic development and on any problems or issues arising during the academic year. Each student is assigned an academic mentor. Students are encouraged to meet with their mentors to reflect on and improve their own academic progress.



"Our LLB Program at CUHK provided me with the assurance and welcome that a first year law student may need. Having come from an international school, there were adjustments to be made, and our program made it easier by giving me the feeling that I would be taken good care of. An example of such would be the Academic Mentorship Program. Once enrolled, each student is assigned to a member of the Academic Staff within the Law Faculty and the student is required to meet with the mentor at least once per term. This program really helped me through my transitional period into becoming a serious law student, and was able to offer not only academic but personal guidance as well when I needed it. Now as I have grown more accustomed and will be commencing my fourth year, I continue to remain a close relationship with both my previous and current mentors, and I am very thankful for what they have to offer. Personal Development Opportunities

The Sir TL Yang Society

"The Sir TL Yang Society" is named in honour of Dr the Honorable Sir Ti Liang Yang, GBM, JP, former Chief Justice of Hong Kong and Honorary Professor of The Chinese University of Hong Kong.

In support of the professional development activities of students, the Society hosts Law High Table Dinners, receptions, lectures and talks in which LLB students can meet with their mentors, alumni and professionals. The activities also provide a platform for the Faculty to maintain close contacts with our students, partners and friends.

The Society provides a travel bursary of up to HK\$10,000 for each LLB student during their course of studies towards the cost of attending the Summer Study Abroad Programme. As part of this programme, students often travel together as a group to attend lectures and seminars provided by host institutions which include visits and exposure to the legal system and culture of the host country.

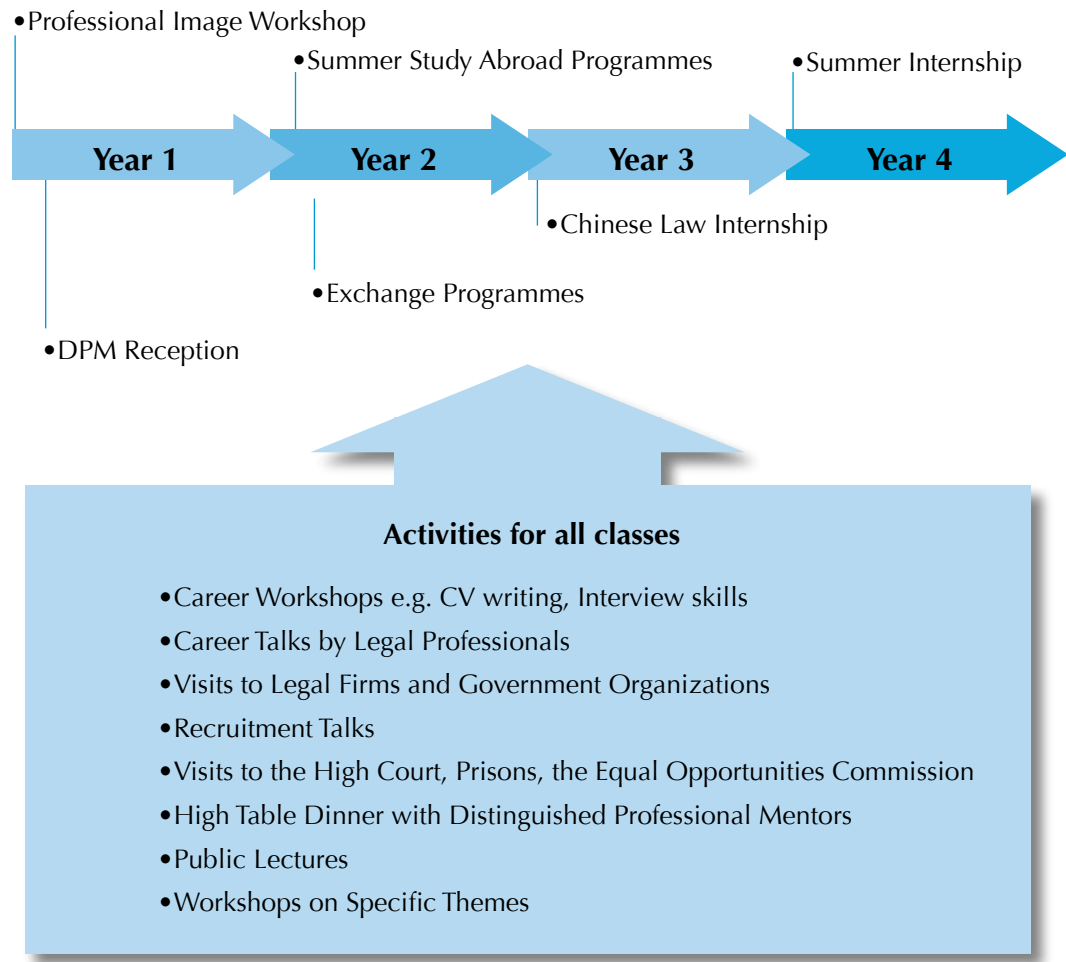

Mooting

What is Mooting?

In 'mooting', law students present written and oral arguments on a hypothetical law case in a courtroom simulation. Among the many moot competitions, the Philip C. Jessup Moot ('the Jessup Moot') in international law advocacy is the oldest, largest and most prestigious moot competition in the world, much like the World Cup for football. Such is the prestige of the competition that judges, lawyers and scholars from across the world willingly give up their time to judge this competition. For the 2009-2010 Jessup Moot Competition, judges included two former Presidents of the International Court of Justice, Stephen M. Schwebel and Dame Rosalyn Higgins.

World Class CUHK Mooting Team

University Law Schools from Hong Kong have participated in the Jessup since 1985. For the past two years in 2008-2009 and 2009-2010, the Chinese University has won the Hong Kong regional championship and advanced to the world finals in Washington, D.C., to represent Hong Kong.

For the 2009-2010 Jessup Moot Competition, our Chinese University team consisted of students from across three degree programmes: Roger Phang (LLB), Vinca Yau (LLB), Patrick Siu (PCLL), Peter Hsiao-pen Chang (PCLL) and Cora Ang (JD). The team achieved an overall ranking of nineteenth in the world from among over 500 teams. Our team also won the Hardy C. Dillard Award for presenting the best written arguments at the competition.



"In the Jessup competition, I was exposed to areas of international law that I had no previous knowledge of and what should have been a frightening experience turned out to be an exciting game of discovery. Wandering through the wilderness of international law, my teammates and I rummaged through numerous doctrines, case law and resolutions. Fortunately, we were not left without guidance from our professors. They constantly reminded us that when the mainstream doctrine is against us, all hope is not lost and we just have to respond with arguments that we will not be embarrassed to make. Such fine advice not only carried us far in this competition but it also 'liberated' my previous 'model answer' approach to studying."

Careers

Law graduates have many career options, both within the legal profession and outside it. They can be a lawyer in private practice or with the government, or pursue a career that draws on a legal background, such as legal academic, legal researcher, law librarian, legal administrator and legal editor. Equipped with sophisticated intellectual and professional skills, they are also much sought after in other professions.

In addition to career services provided at the University level, the Faculty of Law also plays an active role in equipping our students with the skills needed for them to pursue their careers both within and outside the legal profession.

Virtual Careers Resource Centre

Our Virtual Careers Resource Centre is a fantastic resource for students, and is unique to our Faculty of Law. The Virtual Careers Resource Centre not only serves as a contact point for prospective employers, it also provides students with a mass of useful information on developing their career, enhancing skills and presenting themselves to the world in the best possible way.

Career-related Workshops and Activities

Various career-related workshops and activities such as professional image workshop, mock interview workshops, job application and CV writing workshops are organized by the Law Faculty throughout the year for our students.



Career Talks and Company Visits

Recruitment talks and company visits are golden opportunities for students to familiarize themselves with the organizational structure and screening requirements of potential employers. They also provide an interactive environment for both recruiters and potential applicants to gain a mutual understanding with each other. The Faculty arranges such talks and visits on a regular basis for our students.

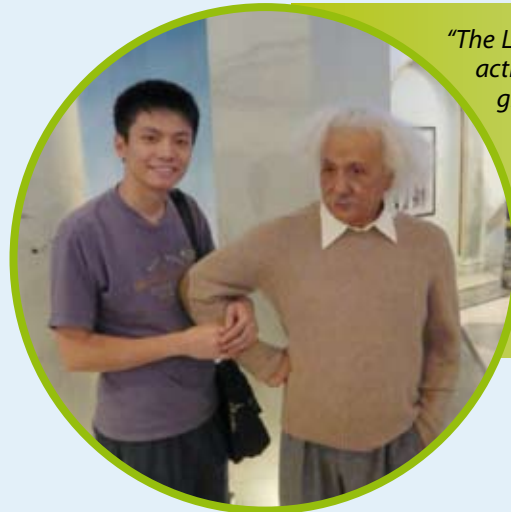
