Students will not be considered for the Scholarships if they have been awarded the same Scholarship before.
2	AIA Scholarships	50,000	Must be permanent residents of Hong Kong; Must have resided in Hong Kong continuously for at least three complete years immediately prior to the commencement of their undergraduate programme; Must have received their senior secondary education in Hong Kong, including those who have studied local (e.g. Hong Kong Diploma of Secondary Education) and non-local (e.g. International Baccalaureate) curricula; Must be local full-time Year 1 undergraduate students in 2023/24, pursuing their first undergraduate degree immediately succeeding completion of their senior secondary school education; Must demonstrate excellent academic performance with a minimum GPA of 3.0 out of 4.0 or equivalent in Term 1 of 2023/24; and Must demonstrate a track record of community service or charitable work undertaken prior to their scholarship application.

This Scholarship will be exempted from the cap on annual total amount of scholarships received by students. The recipients are allowed to hold other admission scholarships concurrently.
